I, Mohit Bajaj, Practising Company Secretary at 1905, 19th Floor, Tower B, Emaar Digital Greens, Golf Course Extension Road, Sector 61, Gurugram, Haryana 122102 had been appointed as Scrutinizer by the Board of Directors of Amco India Limited (hereinafter referred to as "**the Company**") for the purpose of scrutinizing voting through electronic means (remote e-voting and e-voting during the Annual General Meeting) at the meeting pursuant to the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 and Section 108 of the Companies Act, 2013 read with Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014 as amended by the Companies (Management and Administration) Amendment Rules, 2015 read with the Circular No. 14/2020 dated 8th April, 2020, Circular No. 17/2020 dated 13th April, 2020 and Circular No. 20/2020 dated 5th May, 2020 issued by the Ministry of Corporate Affairs (MCA) and Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12th May, 2020 issued by the Securities and Exchange Board of India ("SEBI") in respect of the below mentioned resolutions proposed at the 38th Annual General Meeting ("AGM"/ "Meeting") of the Equity Shareholders of the Company held on Tuesday, the 30th day of September, 2025 at 01:00 P.M. (IST) through Video Conferencing (VC) or other audio visual means (OAVM).

The compliance with the provisions of the Companies Act, 2013 and the rules made thereunder relating to voting through electronic means (remote e-voting & e-voting during the AGM) by the Shareholders on the resolutions proposed in the Notice of the 38th Annual General Meeting of the Company is the responsibility of the management. My responsibility as a Scrutinizer is to ensure that the e-voting process (remote e-voting & e-voting during the

AGM) is conducted in a fair and transparent manner and render Consolidated Scrutinizer's Report of the total votes cast in favour or against, if any, to the Chairman on the resolutions, based on the reports generated from the electronic voting system provided by Central Depository Services (India) Limited (CDSL).

In accordance with the Notice of 38th Annual General Meeting sent to the Shareholders' and the 'Advertisement' published pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 on 5th September, 2025, the remote e-voting opened at 10:00 A.M. on Saturday, the 27th September, 2025 and closed at 5:00 P.M. on Monday, the 29th September, 2025.

Upon the commencement of 38th Annual General Meeting, the e-voting platform was activated to enable the shareholders who were present in the 38th Annual General Meeting through video conferencing (VC) / other audio-visual means (OAVM) and who had not cast their vote on the resolutions through remote e-voting to vote through e-voting facility provided during the meeting. The e-voting facility provided at the meeting was disabled after half an hour from the conclusion of the Annual General Meeting.

The Equity Shareholders' holding shares as on Tuesday, 23rd September, 2025, "cut-off date or record date", were entitled to vote on the resolutions stated in the Notice of the 38th Annual General Meeting of the Company.

I, as the Scrutinizer, unblocked the votes cast by the Shareholders of the Company through the e-voting process, on 30th day of September, 2025 at 06:20 P.M. in the presence of Mr. Ankit Bisht and Mr. Kamal Tanwar, who are not in employment of the Company from the e-voting website of Central Depository Services (India) Limited [CDSL] and the same are being handed over to the Chairman.
